

NEW STUDENT ENROLLMENT CONTRACT 2015-2016

REGISTRATION

The undersigned parent(s) or guardian(s) (hereinafter "PARENTS") hereby enroll ______as a student in grade ______in THE HEBREW ACADEMY (hereinafter "ACADEMY"). PARENTS enclose a non-refundable, non-transferable **registration fee (\$1100.00)**.

PAYMENT OPTIONS

Academy offers three options for payment of Tuition. The three Payment Plans are shown below. The undersigned understands and agrees that if any payment of the selected plan is delinquent, an additional finance charge of 1% will be incurred and shall be payable by PARENTS immediately upon demand by Academy.

Please indicate your choice of Payment Plans below by checking ONLY one. There will be a 1% charge for late payments.

(A)ONE PAYMENT PLAN:	PARENTS agree to pay tuition in full by August 1, 2015.		
(B)THREE PAYMENT PLAN:	PARENTS agree to pay tuition in three equal installments: one third due August 1, 2015		
	one third due December 1, 2015, and the balance due on April 1, 2016.		
(C)MONTHLY PAYMENT PLAN:	AN: PARENTS agree to pay tuition in accordance with the Extended Payment Plan:		
	ten (10) monthly payments, August through May, by post-dated checks, credit card (3%		
	surcharge for Visa, MC, Discover; 4% for American Express), or FACTS Tuition Plan.		

PARENTS AGREE TO BE BOUND BY EACH AND ALL OF THE FOLLOWING ADDITIONAL TERMS AND CONDITIONS OF THIS CONTRACT:

PAYMENT OF TUITION

PARENTS agree to make all tuition payments required by the selected pay plan. PARENTS further agree that should any of the payments not be made on or before the due date specified in the payment plan, the Academy may, at the Academy's sole and absolute option, cancel the child's place and prohibit the child from continued attendance at the Academy.

ADDITIONAL COSTS

PARENTS understand that school trips, parent/teacher organization, selected books, and other miscellaneous fees and charges will be billed at a later date and are not included within the fees and tuition set forth herein. Such additional costs shall be due when billed and payment of such items shall be subject to the provisions of this contract.

PAYMENT OBLIGATION

PARENTS understand that the obligation to pay all amounts in full is a joint and several obligation of the parents and/or guardians of the student who sign this contract. The obligation is unconditional and no portion of any such amounts designated in this contract will be refunded or canceled because of absences, withdrawal, or expulsion, except as set forth in this contract.

PROMOTION AND GRADES

If all fees and payments are not current, prior to the conclusion of the current school year, final grades and transcripts will not be made available.

CANCELLATION

This agreement may be canceled by parents giving written notice of cancellation to the Academy, no later than September 30, 2015. If such cancellation notice is received, PARENTS agree to pay at least one (1) month of tuition, all book fees and the registration fee. After September 30, 2015, PARENTS agree that they are responsible for full tuition as set forth in the contract whether or not their child actually attends the Academy, or withdraws. Upon ANY withdrawal or dismissal of student, all tuition and fees shall become immediately due and payable.

WITHDRAWAL OF STUDENT AT REQUEST OF THE HEBREW ACADEMY:

PARENTS understand that if, after assessment and evaluation, it is determined, in the sole and absolute discretion of the administration of the Academy, that the scholastic and/or behavioral needs of any student cannot be met by the school, the administrator has the right to require that such student be withdrawn from the school. PARENTS understand that ACADEMY reserves the right in its sole and absolute discretion to dismiss or expel any student as a result of any acts of willful or disruptive behavior. Notwithstanding the foregoing, the removal of a child for any other reason shall not excuse the undersigned parents of any student from the financial obligations delineated herein.

INTEREST ON PAST DUE SUMS

PARENTS understand that any amounts specified above which are not paid when due shall bear interest (based on Heter Iska) at the rate of one per cent (1%) of the unpaid balance per month until paid in full; provided, however, that in no event shall such interest exceed the maximum rate permitted by law.

RULES AND REGULATIONS

PARENTS agree to accept and abide by all the rules, regulations, and decisions of the ACADEMY, including without limitation its statements of policy of its Board of Directors as it now exists or may from time to time be amended. PARENTS further acknowledge that PARENTS have received, read and understand all rules, regulations and statements of policy of the Board of Directors.

CONSENT AND AUTHORIZATION FOR PARTICIPATION IN SCHOOL ACTIVITIES AND RELATED BUS SERVICE

PARENTS hereby give full consent and permission for the student enrolled pursuant to this contract to participate in all recreational, athletic and extracurricular activities offered by ACADEMY to its students. PARENTS agree that ACADEMY shall in no way be liable for any accident or injury which said student may sustain in conjunction with any such activity or by the bus transportation service.

WAIVER

In the event of non payment of funds due to ACADEMY, PARENTS agree to waive the California Education Code Sec. 49068.5 and all relevant sections of the Family Education Rights and Privacy Act.

ATTORNEYS' FEES

PARENTS shall pay any and all costs and expenses including actual attorneys' fees and costs incurred in the collection of any of the amounts due herein or the enforcement of any of the provisions hereof.

RIGHTS AND REMEDIES

PARENTS understand that ACADEMY reserves all rights and remedies under the law regarding payments and amounts due under this contract, including the right of offset against moneys and amounts due to parents. ACADEMY'S right of offset includes all sums due on any prior or current contracts signed by any of the undersigned and supersedes the rescission and refund rights set forth herein.

PARENTS HAVE READ THIS CONTRACT AND AGREE TO BE BOUND BY ALL OF THE TERMS, CONDITIONS, AND PROVISIONS SET FORTH HEREIN.
